Potential presenters at the Conference are invited to submit abstracts of their proposed paper for consideration by the Organising Committee. Papers must address the Conference themes and presenters must specify the theme on which they wish to present their paper or work or if they wish to present a poster session. Presentations will be no more than 20 minutes in length although collaborative presentations may occupy a double session of 40 minutes or a full workshop session.

- All abstracts must be submitted in electronic format, in any version of Microsoft Word or a programme that Word can import from. They should reflect the overarching Conference theme 'Mental Health Promotion: From Strength to Strength'. The length should be no more than 400 words and they must arrive no later than **31st December 2004**.
- All correspondence relating to abstracts, including emails, must be in the name of the main author who will remain the main contact point.
- Abstracts should be double spaced and use 12 point Times New Roman font. They should include the title of the paper on one line and the author(s) on a separate line before the body of the abstract, all in 12 point Times New Roman.
